FIRST AMENDMENT TO AFFILIATION AGREEMENT

THIS FIRST AMENDMENT to Affiliation Agreement is entered into by and between EMORY UNIVERSITY, by and through its Emory University Hospital (including Emory University Orthopedic Spine Hospital) and Emory University Hospital Midtown (hereinafter "Emory"), and the Board of Regents of the University System of Georgia by and on behalf of Georgia State University, ("Institution")

WITNESSETH:

WHEREAS, the parties previously entered into an Affiliation Agreement ("Agreement") commencing on January 1, 2016; and

WHEREAS, the Agreement provides that the parties may amend the Agreement by an instrument in writing signed by the parties; and

WHEREAS, the parties now desire to amend the Agreement as follows.

NOW THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

- 1. The Agreement shall be amended to extend the term of the agreement for an additional three years. The renewal of the Agreement is effective on December 31, 2019 and will lapse on December 31, 2022 unless sooner terminated pursuant to the terms of the agreement.
- 2. The Agreement shall be amended to add Emory's Occupational Therapy Internship program as a party to the Agreement (hereinafter Occupational Therapy is included in the definition of "Emory" as used throughout the Agreement).
- 3. Section E7 of Agreement shall be amended to include the Occupational Therapy contact information as follows:

II. SECTION D10 - INSTITUTION RESPONSIBILITIES

Section D10 of the Agreement shall be revised to read as follows:

"10. Institution shall require each participating student obtain a Criminal Background Check for review by designated Emory staff member prior to acceptance for the student clinical experience. In addition, the School shall require each participating student obtain a 12 panel Drug Screen for review by designated Emory staff member prior to acceptance for the student clinical experience. The School shall direct the student to www.advantagestudents.com to fulfill the above requirements, the results of which must be posted for review on www.advantagestudents.com four weeks prior to the start date of the clinical experience."

III. <u>INCORPORATION</u>

<u>Incorporation</u>. This First Amendment to the Agreement shall be incorporated into and made a part of the Agreement; and all provisions of the Agreement not expressly modified or amended hereby shall remain in full force and effect.
